Sole Source Only Justification: Ducks Unlimited (DU) is a critical partner in the implementation of the North American Waterfowl Management Plan in the Saskatchewan Prairie Pothole Region of Canada. It is estimated that up to seventy percent of North American waterfowl breed in this region. Over the past five years with the support of Illinois, DU has conserved, enhanced, and restored over 1.1 million acres of waterfowl habitat. DU has committed more resources to the Prairie Pothole Region of Canada than any other region in North America. Many species of ducks and other wildlife, including threatened and endangered species, live and flourish on DU projects. DU has an aggressive conservation strategy to protect existing habitats and restore lost habitats. DU has developed a waterfowl distribution model based on long-term waterfowl population data and wetland inventory. This tool allows Ducks Unlimited to target its conservation priorities to areas that will have the highest duck pair densities.


