What steps can DNR take to best enhance access to outdoor recreation?</p>	<ul style="list-style-type: none"> • Illinois water law need to be fixed, not good with private areas of river/streams • private landowner liability law needs to be fixed • FEE structure for out of state hunters too low and cheap, Illinois is known as a cheap permit state – not good • For 15-20 years DNR was known as a big leader with the Parks and Conservation Bikeway fund which provided local 50/50 grants. Great bike trails like Hennepin and I&M were developed but those funds have been diverted from original purpose to fund salaries for DNR. These diverted funds have crippled the effectiveness of IDNR. 	<ul style="list-style-type: none"> • promote inexpensive hunting leasing on private lands – also birding/fishing • increase out of state fees • stop diverting special funds to salaries and maintain use for original intent of funding – for capital purposes, not operational
