



# RESIDENT COMMERCIAL FISHING DEVICE LICENSES/TAGS APPLICATION



"Resident" means a person who in good faith makes application for any license or permit and verifies by statement that he or she has maintained his or her permanent abode in this State for a period of at least 30 consecutive days immediately preceding the person's application, and who does not maintain permanent abode or claim residency in another state for the purposes of obtaining any of the same or similar licenses or permits covered by this Code. A person's permanent abode is his or her fixed and permanent dwelling place, as distinguished from a temporary or transient place of residence. Any person on active duty in the Armed Forces shall be considered a resident of Illinois during his or her period of military duty.

You must possess the Initial Commercial Fishing License (available only from the Springfield office) before you can purchase any of the licenses/tags listed below.
