**INSTRUCTIONS & INFORMATION:**

1. Application must be filed with the Department between March 1<sup>st</sup> and September 1<sup>st</sup>. The fee is not required with the application.
2. Class A Hunting Preserve License - Hunting Season: Sept. 1-April 15. Class B License - Hunting Season: All Year.
3. Include a Plat Map and an aerial photograph with the proposed hunting preserve property highlighted or the boundaries outlined.
4. If the proposed hunting preserve or any part of the proposed hunting preserve property is leased, a copy of the lease(s) must be received by the Department before the hunting preserve license will be issued. The term of the lease must be five years.
5. Property included in a licensed hunting preserve must contain at least 200 contiguous acres and cannot contain more than 1,280 contiguous acres. The proposed hunting preserve must also contain at least 100 acres of suitable wildlife habitat.
