- The WSRC agrees to lease Vendor space in the vendor mall or on the grounds of the World Shooting and Recreational Complex to be used for the sale specified food during the aforementioned event. Vendor agrees to comply with all the terms and conditions which are specifically incorporated as part of this agreement.

- The vendor agrees to comply strictly with all Federal, State, Local, and Departmental laws, rules, and regulations. Any permits and/or licenses necessary to perform the work will be secured and paid for by the Vendor. Furthermore, the vendor for the purpose stated herein, is an independent contractor, and as such assumes sole responsibility for the payment of sales taxes and any other taxes incurred or which may become due as a result of the activity specified in this permit. Vendor assumes the responsibility of reporting and paying such amounts due to the Illinois Department of Revenue or other required agencies.

- INDEMNITY AND INSURANCE:** The Vendor shall indemnify and save harmless the State of Illinois, its officers and employees of the World Shooting & Recreational Complex against all loss, damage or expense that it or they may sustain as a result of any suits, actions or claims of any character brought on account of injury to any person or property or death of any person or persons, including all persons performing any work under this contract, which may arise in any way in connection with the work to be performed under this contract. Vendor shall obtain and provide proof of general liability insurance in an amount not less than one million dollars (\$1,000,000) prior to commencing work under this agreement.

- A list of all items offered for sale, along with proposed prices, must be included on the attached page of this permit. If food is sold, vendor agrees to offer for sale only pre-packed food or to prepare from FRESH or FROZEN products daily in accordance with state and local laws and regulations. Futhermore , vendor agrees to obtain food products liability insurance in the amount of Fifty Thousand Dollars (\$50,000) per person, per occurrence and file a copy of said policy with the World Shooting & Recreational Complex prior to the event.

- Vendor shall not enter in construction projects of any kind associated with said vending without the prior written permission of the World Shooting & Recreational Complex.

- This permit to sell shall be in effect upon a World Shooting & Recreational Complex (WSRC) authorized signature.

- The Vendor understands and agrees that upon any violation of or noncompliance with any terms of this permit to sell, the WSRC may terminate this contract immediately by giving the Vendor written notice thereof. Termination for a violation or noncompliance shall be effective immediately upon receipt of such written notice.

- This contract constitutes the entirety of the agreement between the parties and supersedes any other agreement or communication, whether written or oral, that may have been made by either party.
